- 6. All charges shall be payable on demand.7. If any account is overduethe water supply shall be cut off under the provisions of the water (undertakers) rules (Water Act 2002) and proceedings taken to recover the charges due.
- 8. Any changes in the charges shall be notified in the gazette, and in addition details thereoff shall be sent to each consumer with the monthly account preceding such charge.
- 9. The water undertaker shall have the right forthwith and without notice to terminate the agreement for any breach by the consumer to the conditions of supply but without prejudice to any antecedent right against the consumer including the right to take proceedings
- 10. (a) No consumer shall use of permit to be used, any water supplied in pursuance of an application made by him under regulation 3 of these regulations except for such use as specified by him in his application No consumer shall convey, or permit to water supplied to him by water undertakers.
- 11. In accordance with regulation 12 of these regulations, the consumer shall deposit Kshs.................... which shall be retained by the water undertaker for the period during which the consumer is supplied with water.
- 12. The consumer shall meet all charges in respect of water supplied in pursuance of this application and consumer's pursuant to a written request made by him.
- 13. The consumer's responsibility begins immediately after the meter towards his house irrespective of the length of pipe financed by him
- 14. It is the responsibility of consumer to give access to the meter and premises to the water undertaker or his authorised agent who shall reserve the right to disconnect in the event of no such access being granted.
